### **Notable Incidents**

On 01/05/21 at approximately 11:45 pm, BPS officers responded to a person shot at Family Fare, 110 Central Ave. BPS officers arrived on the scene and learned that the shooting occurred at Twin Circles Mobile Home Park, 800 East C St., and the victim drove himself to Family Fare. The victim was shot in the leg and was transported to a local hospital for treatment. During the shooting, a house and a vehicle were also struck by gunfire. No other injuries were reported. Investigators were able to identify a 17-year-old juvenile as the suspect. On 01/08/21, BPS investigators and patrol officers took the juvenile into custody without incident. A stolen firearm, which is also believed to be the weapon used in the shooting was recovered. As a result of the investigation, Sgt. N. Williams obtained juvenile petitions charging the juvenile with one count of assault with a deadly weapon with intent to kill inflicting serious injury, one count of assault with a deadly weapon with intent to kill, one count of firing into an occupied/moving vehicle, one count of firing into an occupied dwelling, possession of a stolen firearm, and attempted larceny from the person. The juvenile has been transported and transferred to a juvenile detention facility.

### **Chief's Notes**
