Notable Incidents

On 3/31/2023, A 2017 Chevrolet Camaro was stolen from Granville Oaks Apartments. With the use of a vehicle monitoring system, the vehicle was located on Ridgeway Ave. in Durham and returned to the owner the same day. Multiple other stolen vehicles were located in the same parking lot which were turned over to Durham PD. The investigation is still underway.

On 04/01/2023, A robbery was reported at 1203 East E Street. The victim alleged that a suspect threatened physical violence and took \$1,200 dollars in money. The victim knew and identified the suspect. Investigations Lieutenant N. Williams obtained a warrant for Dexter Hart. Mr. Hart was located by SPSO Spitzer and taken into custody. Mr. Hart is held in the Granville County jail under a \$60,000 secured bond.

Chief's Notes

Training hours overview- From March 27-April 25, Butner Public Safety employees participated in 357 hours of in-house training and 32 hours of external training. This includes all training that is attended by Public Safety Officers, Firefighters, Telecommunicators, and civilian personnel.

Public Safety Officer Cody Coeburn has completed all the classes required for his Firefighter II certification and has been employed at Butner Public Safety for two years. He has now been given a vehicle as part of our Assigned Vehicle Program.

The external body armor that was awarded from the JAG Grant has arrived and been placed in every BPS patrol vehicle. Each vehicle has also been outfitted with a ballistic helmet also.
