Notable Incidents

On Monday, May 22, 2023, Butner Public Safety hosted a traffic enforcement event as part of the Governor's Highway Safety Program. Multiple agencies were invited to participate such as the Granville County Sheriff's Department, the NC Highway Patrol, and equipment was lent by the Creedmoor Police Department. The traffic enforcement event resulted in 81 vehicle stops. Of those stops, 41 citations were issued for charges such as speeding, license violations, registration violations, failure to wear a seatbelt and failure to move over for law enforcement vehicles.

On May 15, 2023, Sgt. T. Currin observed a vehicle on NC 56 whose owner had warrants for their arrest. A vehicle stop resulted in the discovery of 167 grams of marijuana, Xanax, Oxycodone, and crushed Oxycodone. The driver also provided a false name. Jawara Hargrove of Kittrell was charged with identity theft, felony possession of marijuana, possession with intent to sell and distribute marijuana, trafficking narcotics, and simple possession of schedule II. Mr. Hargrove was also served multiple outstanding felony warrants from other jurisdictions. He was placed in the Granville County jail under a \$256,000 bond.

On April 28th, 2023, a search warrant was executed at 603 15th Street. Mr. Kristopher Autry of 603 15th Street and Allyson Culbreath of 1021 Fate Washington Road Stem, NC were arrested and charged with possession with intent to manufacture, sell, and deliver cocaine, possession of schedule I, and possession of drug paraphernalia. Mr. Autry was placed in the Granville County Detention Center under a \$20,000 secured bond. Ms. Cullbreath was also placed in the Granville County Detention Center under a \$7,000 secured bond.

On April 25th, 2023 a search warrant was executed at 207 East C Street. Ms. Sarah Newton and Mr. Darquawn Cozart were arrested and charged with possession with intent to sell, manufacture and deliver cocaine, possession with intent to sell, manufacture and deliver heroin, possession with intent to sell, manufacture and deliver methamphetamine, possession with intent to sell, manufacture and deliver marijuana, maintaining a dwelling for controlled substance, possession of schedule II, and possession of drug paraphernalia. A bond of \$95,000 was issued.

Chief's Notes

Training hours overview- From April 25-May 23, Butner Public Safety employees participated in 618 hours of fire training and 285 hours of law enforcement training. This includes all training that is attended by Public Safety Officers, Firefighters, Telecommunicators, and civilian personnel.
