Notable Incidents

On 10/23/21 at approximately 8:46 p.m., BPS officers responded to Twin Circles Mobile Home Park, 800 East C St., in reference to two people that had been shot. BPS officers arrived on the scene to find that an 18- and 21-year-old male had been shot multiple times. Granville EMS transported both males to the hospital. Officers learned that the shooting occurred in the parking lot at Piedmont Village Apartments, 600 East B. St. While in the process of investigating the shooting a Butner firefighter observed a vehicle in the area of Central Regional Hospital driving erratically and without headlights. The firefighter called Granville 911 with the information. A Granville County Sheriff's Office Deputy attempted to stop the vehicle on Central Ave. in Butner. The vehicle did not stop, and a chase ensued. Granville County Sheriff's Office and Butner Public Safety chased the vehicle where it crashed in Durham. Two occupants of the vehicle fled, and two occupants remained in the vehicle. The two 19-year-old occupants that remained in the vehicle were determined to be suffering from gunshot wounds and were transported by Durham EMS to the hospital. Officers learned that these males were also shot at the Piedmont Village Apartments location. The incident is still under investigation. There were no additional injuries or collisions associated with this incident as reported in other news outlets.

Chief's Notes

BPS had our first departmental meeting since I became the director and COVID shut large gatherings down. BPS provided a meal and DA Mike Waters came and provided valuable information to the department members regarding SB 300 which was enacted as Session Law 2021-138. Mrs. Davis covered the new vaccine incentives, COVID policies, the CRH incentive and the upcoming promotional assessment. Capt. Bryant reviewed the new Noise Ordinance that was passed by the town council recently and I went over budgetary information, CRH responsibilities, training, internal items. The employees were also given a chance to provide comments and ask questions.

BPS is currently seeking applications to fill three positions. One is open, the second is for an upcoming retirement and the third is for a resignation.
