Notable Incidents

On September 9th, 2021 at 2313 hrs, a shooting occurred in the PVA of Madison Pointe Apartment Complex. The victim was shot at several times, one striking his foot. The shooting was a result of a domestic argument. Mr. Marcus McNeil of Franklinton was transported to the hospital with a non-life threatening gunshot wound to his foot. Mr. Andrew Sills of Oxford was charged by Investigator N. Williams with assault with a deadly weapon with intent to kill. He was given at \$90,000 secured bond and remanded to the Granville County Detention Center.

Chief's Notes

On 9/23/21 after a joint investigation between the Granville County Sheriff's Office and Butner Public Safety, Derrick Beulah and April Miller were taken into custody. Both subjects were charged with many of the recent Breaking and Entering incidents that had been reported out in the county. Sgt. Tyler Currin of BPS responded to conduct a check at the Depot for two people passed out in a vehicle. Upon speaking with the individuals Sgt. Currin spotted a firearm concealed in the center console of the vehicle. Sgt. Currin was already aware of the possibility that the two were involved in the break ins out in the county. Further investigation led to the discovery of possible stolen items that were reported to the Granville County Sheriff's Office. Both subjects were arrested for possession of a stolen firearm and Beulah was also charged with felon in possession of a firearm. The vehicle was turned over to the sheriff's office for further investigation.
