
Let your dreams be known for what you want Butner to become. Come and participate in the open house for Butner's 2040 plan on September 10th. You can influence the Town for generations to come.

Butner Development Suitability

The foundation of the Imagine Butner 2040 Comprehensive Plan is the Mapping and Suitability Analysis which is a road map that shows us where development should go based on data about lands **Most Suitable** for new development like existing infrastructure including water, and sewer; is the land too



steep or wet for largescale development; how accessible is it? Are the roads large enough to handle the traffic generated (building new roads to serve new development is very expensive).

The Analysis then looks at Land Supply: how much land is available for development, including vacant parcels, underutilized parcels and unavailable, or utilized, parcels.

And finally, helps us to plan for **Fiscal Responsibility.** Developing in areas with infrastructure maximizes the public's investment. The Butner 2040 website (www.butner2040.com) goes into much more detail about these factors. The map here is a summary of lands most suitable for development overall.



Roberts Chapel Trail

Plans are underway to create public hiking trails on a 55-acre property owned by Tar River Land Conservancy (TRLC) near the Town of Butner. The trailhead will be located at 792 Roberts Chapel Road, which is located north of Lake Holt just 9 minutes from Butner Town Hall.

The property is located in Butner's Extra-Territorial Jurisdiction, which is an area outside of Butner's corporate limits but inside its Planning jurisdiction. TRLC is working with the Butner Planning and Zoning Department to secure permits for the trail project. Once opened to the public, TRLC plans to name the property the "Roberts Chapel Conservation Area." TRLC's property is located across the road from the site of the former Roberts Chapel Church, which existed before Camp Butner was established.

Trail construction is expected to begin this fall and continue for several months. TRLC's goal is to open 1½ miles of hiking trails to the public by spring 2021. Trails will start at a small gravel parking area and then wind through beautiful hardwood forest and along small streams that supply water to Lake Holt.

The Roberts Chapel Conservation Area will be TRLC's second property opened to the public for hiking. TRLC maintains five miles of trails at the Ledge Creek Forest Conservation Area located northeast of Butner.

TRLC is seeking volunteers to help build the new hiking trails. Trails will be constructed using hand tools such as brush clippers, rakes, and hoes. New volunteers will receive training from TRLC staff. To learn more, please send an email with your contact information to volunteer@tarriver.org or call (919) 496-5902.

Planning staff is working with TRLC, and with NCDOT and Durham City/County Planning staff on additional recreation opportunities for Butner residents including more trails and access to open space. A few good resources for you include: www.tarriver.org, www.ncdot.gov/divisions/bike-ped.
